

## **GENERAL CONDITIONS OF ACCESS AND USE OF THE WEBSITE**

Lácteos García Baquero, S.A. , a Spanish company, with Corporate Tax Code A-13010004 and registered address at C/ Syrah, 4 de Alcázar de San Juan (Ciudad Real), Spain, registered in the Ciudad Real Companies' Registry on 05 December 1979, in Volume 71, folio 63, page number 309, 1<sup>st</sup> inscription, would like to inform Users who access or use the services, applications, tools and contents in general included on this website of the Conditions of Use that apply to the access and browsing of this website.

Users accept these Conditions of Use by merely accessing the website. Lácteos García Baquero, S.A. reserves the right to amend these Conditions of Use at any time.

### 1.- Responsibility of Users regarding use and contents.

The User undertakes to use the services or contents in accordance with current legislation and in good faith, exclusively for their personal use, and not to make direct or indirect commercial use thereof. It is expressly forbidden, without this being limiting in nature, to violate the rights of third parties regarding their privacy, honour, own image, secrecy of communications, intellectual and industrial property or personal data protection.

Lácteos García Baquero, S.A. does not accept any form of liability derived from the misuse of services or contents by Users or third parties.

Users are solely responsible for all acts or omissions made with their account and/or password, as well as with the content of the communications that they make through this website.
